This contract is subject to the following terms and conditions:

1. Rental rate shall apply for the entire time equipment is away from Lessor's place of business regardless of weather, but not for lost time due to mechanical failure, unless caused by lessee or his agents or servants.
2. The lessee is responsible for any personal injury or property damage while the equipment is in the possession of them.
3. The lessee agrees to use this equipment in a responsible manner and only for the purpose for which it is intended.
4. The lessee acknowledges having and understands the instructions regarding the use and operation of the equipment.
5. The lessee agrees to clean the equipment after the use and return to Bloomfield Feed Co. in the same condition that it was rented or to be subject to a cleaning charge. (\$50.00)
6. The lessee will assume full responsibility for the equipment while it is in the lessee's possession. If the equipment is lost or stolen, the lessee agrees to pay full value and if damaged the lessee agrees to pay cost of repairs in full.
7. The lessee is responsible for fuel and lubrication and shall keep the equipment lubricated at all times. The lessee is also responsible for damage to tires.
8. Title to the equipment shall at all times be vested in the lessor.
9. The lessee has no right to sub lease equipment. The equipment is to be used solely by the lessee and kept within the lessee's possession and under its control.
10. The lessor reserves the right to cancel his contract at any time it may consider it necessary to protect its property.
11. The lessor shall use reasonable care to see that the equipment is in proper working condition before it is in the possession of the lessee.

12. The lessee accepts the equipment as being in good mechanical condition capable of safe operations and agrees to return it to Bloomfield Feed Co. in the same condition.
13. The person both signing and name on the front of his contract agrees to be responsible for the contract. If the named lessee is a business, corporation, partnership the person signing declares that they are authorized to sign the contact.
14. The lessee will only allow trained persons to use the equipment that is rented.
15. The lessee is responsible for equipment loss or damages due to theft or mysterious disappearance or by loss or damages caused by customer negligence.
16. The lessee will maintain at the lessee's expense liability, property and casualty insurance coverage in an amount designated by Bloomfield Feed Co. and sufficient to fully protect the lessee and rental equipment from and against any and all claims, loss or damage of whatever nature or type. The lessee agrees to pay Bloomfield Feed Co. any funds her or she receives from the lessee's insurance company with respect to damage to or loss of equipment.
